# ORGANIZATIONAL OVERVIEW & RANKINGS

BONNER COUNTY AMATEUR RADIO CLUB INC is a based in PONDERAY, ID, focused on Human Services - Multipurpose and Other causes , specifically Human Services - Multipurpose and Other N.E.C.. Established in April 2002, it operates as an independent corporation and contributions to this organization are tax-deductible .

With total assets of \$0.00, this ranks 1,008,912 among 2,656,690 nonprofits nationally (Top 38%), demonstrating moderate financial capacity relative to its peers. At the state level, it stands at 7,560 out of 14,700 organizations in ID (Top 52%).

In bonner county, ID, the organization ranks 283 out of 540 nonprofits by assets (Top 49%), while locally in ponderay, it stands at 17 among 26 organizations (Top 17%).

The organization reported no revenue in the most recent filing period, placing it at 1,304,541 nationally and 9,760 in ID.

Within its specific NTEE classification (P99 - P: Human Services - Multipurpose and Other), which includes 18,561 similar organizations, BONNER COUNTY AMATEUR RADIO CLUB INC ranks 4,454 in assets (Top 24%) and 6,374 in revenue (Top 35%).

The organization files a 990 - Required to file Form 990-N - Income less than \$25,000 per year and operates on a November fiscal year.
